# 安装距离选择

要选择一个较容易探测到入侵者的安装位置(我们建议装在某个角落)。参见探测范围图图.4。四元红外传感器探测横穿过探测光束的移动非常灵敏,相对而言,探测朝向探测器方向的移动灵敏度就要低一点。推荐安装高度为1.8米到2.4米

避免以下的安装位置

- 直接面对太阳光,被直射。
- 朝向可能产生温度快速变化的区域。
- 空气尘大,气流大的区域.

当周围环境较稳定无杂音信号干扰时,CR-1000Pl 探测器能够表现出最好的性能。

### 探测器安装


该探测器可以选择墙装或角落装。

如果需要吸顶安装或一些特殊墙面安装,建议使用可选配件中的专用支架。参见支架描述(见图 7)。

1. 取下螺丝,轻轻的打开探测器外壳(见图 1)。



2. 取下 PCB 主板上的固定螺丝,卸下 PCB 主板. 3. 根据走线方式,打通背面的走线孔.

- 4.底部一些圆形及方形的缺口是用做线孔的。用户也可以使用未作固定用的定位孔来走线。 (选用支架时,线缆由支架中穿过-图.7)
- 5. 将探测器固定于墙壁, 角落或天花板. (选用支架安装时见图 7)
- 6. 重新上好 PCB 主板,固定好螺丝,将线缆接入接线端 子
- 7. 将外壳盖好,装上螺丝


- 1. 打开外壳



# 探测器设置

### 报警信号 LED 指示

开关 1 用于设定 LED 灯的开关状态 位置在上时-ON-LED 打开 LED 打开. 当探测器探测到入侵时, LED 会亮起 位置在下时 Down – OFF - LED 关闭 LED 关闭, LED 灯被关闭.




